# General Food Booth Information

## Indian Market Dates & Times

The 2018 SWAIA Santa Fe Indian Market begins on Saturday, August 18th and ends on Sunday, August 19th at the Santa Fe Plaza and surrounding streets. Snack vendors are required to sell both days of Indian Market and only during the official Indian Market hours of:

<b>Saturday</b>	<b>7:00am – 5:00pm</b>
<b>Sunday</b>	<b>8:00am – 5:00pm</b>

## Fees

Application Fee of \$25.00 is due when applying. Upon acceptance to participate, the booth fee is \$1,000.00. The booth fee is divided in half: 1<sup>st</sup> payment of \$500.00 is due at the Mandatory Food Vendors Meeting and the balance must be received by Thursday, August 9, 2018.

## \*Eligibility:

Individuals of American Indian descent who can provide official documentation from a U.S. Federally recognized tribe or First Nations of Canada are eligible to apply as an Indian Market snack vendor.

## Booth Assignments:

All applicants will be notified of their status in April. If selected, you will be required to:

- Fill out a Food Booth Agreement (packet to be provided by SWAIA).
- Attend a Mandatory Food Vendors meeting (May/June 2018)
- Provide SWAIA with a copy of Liability Insurance
- Payment schedule: ½ to be paid at Mandatory Meeting, the other ½ to be paid by August 9, 2018.
- Fill out the Special Events License Application (form on SWAIA website) and return with application.

## Booth Spaces & Location:

All vendors will be notified about their location on the plaza when selection is made in March. If selected as a participant, all vendors must comply with SWAIA rules, the City of Santa Fe fire codes and guidelines for food vending and the New Mexico State Environmental regulations.
